GOT 2 DANCE PRODUCTIONS - Policy and Fee Contract

The registration fee of \$20/dancer or \$30/family must be submitted with the registration form to officially register a dancer in classes at Got 2 Dance Productions for the dance season. The registration fee is non-refundable. All lesson fees, including post-dated cheques, must be handed in with the registration form.

All studio communications (monthly newsletters) will be distributed via email only, so please print your email address clearly and notify G2D of any email address changes throughout the season. Printed copies will be available on the studio bulletin board each month as well as posted online.

There is a \$25 NSF charge for all returned cheques.

If your account is not up to date a dancer may not participate in classes or functions with Got 2 Dance Productions. If after one month your account is still not up to date, Got 2 Dance Productions may have to withdraw your child out of the program and a late fee will be applied.

There are no refunds for periodic absences.

Monthly payments: families choosing this option must include post dated cheques for the year.

Lesson fees are non-refundable unless a 30 day written notice is handed in. Lesson fees up to and including the current month's notice of withdrawal, including the 30 day notice, and May's fees are non-refundable. After the 30 day notice, any money owing to the family will be applied. If written notice is given mid-month, the amount returned will be pro-rated. Lesson fees will not be returned after March 31.

There are fees above and beyond the cost of lessons which include class attire, costume fees, festival fees, Got 2 Dance Productions shows and Got 2 Dance Productions attire, all of which are non-refundable.

Costume deposits are due no later than November. If Got 2 Dance Productions does not receive these fees, the costume will not be ordered.

Festival fees are due no later than January. If Got 2 Dance Productions does not receive these fees, your dancer will not be able to participate in festivals.

Dancers who miss more than three unexcused absences may be asked to leave the program. All absences must be phoned or e-mailed in by a parent.

Dancers must always be prepared to dance when they arrive at the studio. They will wear their proper class attire and have their hair pulled off their face for every class. Dancers are allowed to bring water bottles and small snacks for in between classes. Dancers are to respect the facility, the teachers and their fellow dancers.

All cell phones must be turned off and left in the dancer's bag during their classes. No chewing gum during class.

The studio's policies and guidelines must be reviewed with your dancer and then understood when any measures taken by G2D staff are needed if the policies are not adhered to.
